# SUBRECIPIENT AGREEMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT – NATIONAL DISASTER RESILIENCE PROGRAM

WHEREAS, on or about October 26, 2016, the CITY OF SPRINGFIELD, a municipal corporation within the County of Hampden, Commonwealth of Massachusetts, with its principal offices at 36 Court Street, Springfield, Massachusetts, 01103, acting by and through its Chief Development Officer, with the approval of the Mayor (collectively referred to herein as the "City"), entered in a Sub-recipient Partnership Agreement referred to as City Contract No. 20170335 ("Agreement") with Baystate Health, Inc., a not-for-profit corporation with its principal place of business at 759 Chestnut Street, Springfield, Massachusetts, 01199 (hereinafter "BH" or the "SUBRECIPIENT"), to provide partial funding for the construction of a Combined Heat and Power Plant (CHP) at Baystate Medical Center, located at 759 Chestnut Street, Springfield, MA., through a CDBG-DR grant from the U.S. Department of Housing and Urban Development (the "Project"); and

WHEREAS, Amendment #1 to the Agreement changed the Subrecipient from Baystate Health, Inc. ("BH"), to Baystate Medical Center, Inc. ("BMC"), which is a wholly owned subsidiary of BH; and

**WHEREAS**, the City and BMC have agreed to extend the time for performance of the grant services in Article I(D)(1) from January 1, 2018 to June 30, 2018;

**NOW THEREFORE**, for good and valuable consideration, the City and the Sub-recipient agree to amend the Agreement as follows:

- 1) This Amendment #2 is executed pursuant to Article IV, Section (G) of the Agreement.
- 2) <u>Article I, Section (D)(1), Time of Performance</u>, is hereby amended by extending the completion date from January 1, 2018 to <u>June 30, 2018</u>.
- 3) All other terms and conditions of the Agreement, not amended herein, shall remain in full force and effect.
