AMENDMENT #2 TO CITY CONTRACT NO. 20131154

**AGREEMENT FOR ON-CALL PROFESSIONAL
ARCHITECTURAL SERVICES**

**PROJECT ORDER FOR WORK AT THE
MARY A. DRYDEN VETERAN'S MEMORIAL SCHOOL**

WHEREAS, on or about June 26, 2013, the **City of Springfield, MA.**, a municipal corporation with a principal place of business at 36 Court Street, Springfield, Hampden County, Massachusetts, 01103, acting by and through its Department of Capital Asset Construction and the Department of Parks, Buildings and Recreation Management, with the approval of its Mayor (collectively referred to as the "City" or "OWNER") , entered into an "Agreement for On-Call Professional Architectural Services" referred to as City Contract No. 20131154 ("Agreement") with the firm of DRUMMEY, ROSANE ANDERSON, INC., a legal entity incorporated under the laws of Massachusetts, with a principal place of business at 235 Bear Hill Road, Waltham, MA. 02451 (hereinafter the "ARCHITECT"); and

WHEREAS, the Agreement provided for the ARCHITECT to provide architectural services to the City on an on-call basis, with projects to be added to the Scope of Services by amendments to the Agreement, pursuant to Article I(D); and


WHEREAS, the OWNER and the ARCHITECT wish to amend the Agreement to add another project to the Agreement, according to the terms and conditions of this Amendment #1;

NOW THEREFORE, the parties agree to amendment the Agreement as follows:


1. Pursuant to Article I(D)(1)(c), Scope of Services, of the Agreement, the OWNER has requested that the ARCHITECT perform certain architectural services at the **Mary A. Dryden Veteran's Memorial School Project** ("Dryden Project"), consisting of Furniture and Equipment Services (for a fee of \$24,000.00), and Technology Equipment Design and Procurement Services (for a fee of \$23,645.00), all as further described in the proposals attached hereto as Exhibit A-1 and A-2. The total fee to the ARCHITECT for the work described in this Amendment #2 is \$47,645.00.
2. Pursuant to Article XI, Amendments, of the Agreement, the ARCHITECT shall be compensated for the services described in this Amendment #2 in an amount not to exceed Forty Seven Thousand Six-Hundred Forty-Five and 00/100 Dollars (\$47,645.00). DRA shall invoice the OWNER monthly for the cost of these services, or as otherwise mutually agreed upon by the parties.
3. All other terms and conditions of the Agreement, no amended herein, shall remain the same.

IN WITNESS WHEREOF, the City of Springfield, acting by and through its Department of Capital Asset Construction, and the Department of Park, Buildings and Recreation Management, with the approval of its Mayor, and the ARCHITECT, Drummey, Rosane, Anderson, Inc., have set their hands and seals on this Amendment #2 as of the date the same is signed by all necessary parties listed on the signature page hereto.






