# CODE ENFORCEMENT DEPARTMENT

#### **Building Division Highlights for Month of August**

- Building Division issued 227 construction permits to Erect, Alter, Repair or Demolish with an estimated construction value of \$6,449,342.00 for the month of August with a fiscal year to date total of \$47,424,623.
- Fiscal year to date, the building division has issued new construction permits for two, new single family dwellings, and one, two family dwellings, and 161 residential permits to add to and alter a single family or two family dwellings, 16 new construction permits for non residential buildings, 42 permits to add to and alter a nonresidential building and 3 permits to demolish a structure.
- Special attention was given to fast track the Building Permit for \$300,000.00 for the new construction of a 2 family house located at 47-49 Kent Road in the month of August.
- Also, in the month of August, \$1,489,150.00 worth of building permit renovations for the second floor of Valley Medical Associates building, 3550 Main Street, was issued.
- Buildings condemned in August 2010; 244-252 Locust Street, both buildings.

### **ZONING DIVISION**

- <u>37 Grove Street</u> This property was being used for illegal dumping of bulk items, trash, and debris. The property is now completely cleaned, and is in compliance.
- Rear Front Street, Indian Orchard, parcel #20 This property was being used as an illegal junkyard which contained large amounts of used and/or discarded items strewn about. This parcel has also been cleaned.






## Building Revenue Trend Analysis FY 2004-2010 Month of August 2010 Total 91,838.00
