


Consolidated Plan – What is it?

- Document required by HUD
 - Citizen Input
 - Other Studies & Plans
 - Data Analysis
 - Priorities and Goals
- Approximately \$6 million annually
- Tied to 3 funding resources, CDBG, HOME, ESG and HOPWA
- Five—Year Time Period
 - July 1, 2025 June 30, 2030



Public Input

- Public Hearing #1 December, 2024
- Meetings with Community Stakeholders in December
- Surveys were available through December 31, 2024
 - 1100 Responses (English)
 - 91 Responses (Spanish)









Neighborhood Plans

- 12 of 17 Neighborhoods have been disproportionately impacted by COVID
- 1 is Ongoing (Forest Park)
- 3 are in Draft Form (Metro Center, North End, South End)
- 5 are through Phase 1 drafting (Bay Area, Maple High/Six Corners, McKnight, Old Hill, Upper Hill)

Currently the City is funding the follow affordable housing and/or homelessness prevention programs:

-Down payment Assistance for First Time Homebuyers

-Homeowner Repair Programs

- -Tenant Based Rental Assistance
- -Permanent Supportive Housing and Rapid Rehousing
- -Development of Affordable Rental Housing
- -Development of Affordable Single-Family Homeownership Opportunities
- -Repair and/or Replacement of heating systems
- -Overnight and Emergency Shelter for Homeless
- -Short Term Rent, Mortgage and Utility Assistance
- -Street outreach to unsheltered individuals

Currently the City is funding the following public and community service programs:


-Park improvements

- -Elderly programming for senior center
- -Food access and/or food pantry programming
- -Substance abuse and/or recovery programming
- -ESOL Programming
- -Programming to house mothers with children that are homeless or at risk of homelessness
- -Mental health programming
- -Funding for neighborhood council activities and programming
- -Social/public service navigation
- -Non-Profit COVID-19 Assistance
- -COVID-19 Stabilization Programming for Neighborhood Councils and Communities


If you could prioritize the top 3 programs or services listed above over the next five years, what would they be? Are there programs or services that you think are missing from this list?
