Chapter 38 of the City Ordinances or M.G.L. Chapter 3, § 41 requires every executive and legislative agent to file Form L2 within ten days after entering his name upon the docket. Form L2 is the written authorization to act as such agent, signed by the employer on whose behalf the executive or legislative agent assumes to act.

Violation of any provisions of Chapter 38 of the City Ordinances or M.G.L. Ch. 3, § 40-47 shall be punished by a fine of three hundred dollars (\$300).
