AMENDMENT TO HEALTHY HOMES REHABILITATION PROGRAM AGREEMENT (CONTRACT #20190358)

AGREEMENT, made the day of April, 2019 by and between Earl Baidy and Yvonne Baidy with an address of 57 Dexter Street, Springfield, Massachusetts (hereinafter referred to as the "Borrowers") and the City of Springfield through its Deputy Director of Housing, with the approval of its Mayor (hereinafter referred to as the "City") regarding the rehabilitation of the property at 55-57 Dexter Street, Springfield, Massachusetts.

WHEREAS, the City and the Borrowers wish to amend the rehabilitation amount within the existing Agreement;

NOW, THEREFORE, the parties hereto agree that their Agreement shall be amended as follows:

- 1. Increasing the original contract amount of \$82,525.00 (Eighty-Two Thousand, Five Hundred Twenty-Five Dollars and Zero Cents) to an amended total of \$86,727.50 (Eighty-Six Thousand, Seven Hundred Twenty-Seven and 50/100 Dollars).
- 2. All other terms and conditions remain the same.




