AMENDMENT #3 TO CITY CONTRACT NO. 20180082

GRANT AGREEMENT

WHEREAS, on or about August 1, 2017, the CITY OF SPRINGFIELD, a municipal corporation within the County of Hampden, Commonwealth of Massachusetts, with its principal offices at 36 Court Street, Springfield, Massachusetts, 01103, acting by and through its Office of Disaster Recovery and Compliance, with the approval of the Mayor (collectively referred to herein as the "City"), entered in a Grant Agreement referred to as City Contract No. 20180082 ("Agreement") with The Regional Employment Board of Hampden County, Inc., a not-for-profit corporation with its principal place of business at 1441 Main Street #136, Springfield, Massachusetts, 01103 (hereinafter "REB" or the "SUBRECIPIENT"), to offer a Construction Skills Training Program ("Program"); and

WHEREAS, The Regional Employment Board of Hampden County, Inc. ("REB"), works through federal and state funding; and

WHEREAS, the REB has changed their name from the Regional Emloyment Board of Hamden County, Inc., to MassHire Hampden County Workforce Board, Inc., ("MassHire") in order to create a uniformity for all of the workforce programs within the Commonwealth;

NOW THEREFORE, for good and valuable consideration, the City and the Sub-recipient agree to amend the Agreement to: change the name of the Sub-recipient from The Regional Employment Board of Hampden County, Inc., to MassHire Hampden County Workforce Board, Inc. on the following terms and conditions:

- 1) This Amendment #3 is executed pursuant to Section IV Sub-Section G of the Agreement.
- 2) Where the parties have agreed to change the name of the Sub-recipient in the Agreement from The Regional Employment Board of Hampden County, Inc., to MassHire Hampden County Workforce Board, Inc., the introductory paragraph on page 1 of the Agreement is hereby deleted in its entirety and replaced with the following paragraph:

"Upon execution by all parties, this Agreement, shall be effective as of entered into as of the 1st day of August, 2017, BY AND BETWEEN **MassHire Hampden County Workforce Board, Inc. ("MassHire"),** a not for profit corporation with its principal office and place of business at 1441 Main Street #136, Springfield, MA 01103 (hereinafter referred to as the "SUBRECIPIENT"), and the **CITY OF SPRINGFIELD,** a municipal corporation, duly organized and in existence under the laws of the Commonwealth of Massachusetts, with its principle office and place of business at 36 Court Street, Springfield, Massachusetts 01103, acting by and through its Office of Community Development and Disaster Recovery and Resilience Department, with the approval of its Mayor (hereinafter referred to as the "CITY").

3) To the extent that this Amendment #3 constitutes an assignment of the REB's interest in the Agreement for purposes of <u>Section IX Sub-Section D(1)</u> of the Agreement, the City hereby gives its written consent to such assignment. Upon execution of this <u>Amendment #3</u> by the duly authorized agents of each party listed on the signature page hereto, all rights, interests, obligations, warranties and covenants of the REB in and under the Agreement shall be

immediately assigned, transferred and conveyed to MassHire without further action by any party.

4) All other terms and conditions of the Agreement, not amended herein, shall remain in full force and effect.
