The Outer Belt Civic Association is submitting an application for CPA-recreation category funding to make improvements to Treetop Park. Treetop Park, an approximate 17-acre park, is located in the Outer Belt neighborhood of Springfield at Corcoran Street.

The Outer Belt Civic Association is applying for CPA 2024 funding to make improvements to Treetop Park that will increase park usage by neighborhood and city residents. Treetop Park offers soccer fields, playground, a woodland, parking and comfort station. The Park is actively used by the neighborhood and youth soccer organizations and improvements to the park will provide visitors with more amenities to enjoy. Specifically, proposed park improvements include installation of a stone dust surface walking path and accessible swing set. This project meets the following CPA priorities: to preserve and enhance the essential character of Springfield; to demonstrate practicality and feasibility so the project can be implemented within budget and on schedule; has received endorsement from municipal boards/departments and from the neighborhood association; and will utilize Springfield based resources when possible. Improvements to Treetop Park will meet the CPA goals of renovating small neighborhood playgrounds and green spaces, and of creating and enhancing opportunities for trails on parkland.

Treetop Park Improvements includes design and construction activities to install a 5 ft. wide stone dust walking path and accessible swing set at Treetop Park. The proposed walking path will connect around the soccer field to the swing set and playground area. Treetop Park does not currently have a walking path. Many neighborhood residents incorporate the park in their daily walks, and the addition of a walking path will allow them to use more of the park. The Park does not have swings for people to enjoy. The proposed swing set will complement the existing playground to offer both traditional and accessible swings for all to utilize. The OBCA will work with the Park Department to implement the project and determine what style amenities are best suited at the site. Design development, beginning when CPC & Parks contract is complete, will advance the concept plan into permitting, construction plans and documents. Construction activities will include all necessary tasks to install proposed site amenities. The Construction timeline is anticipated as fourteen months to accommodate unforeseen delays, weather and/or product availability impacts. The proposed project included both design and construction elements to improve the site conditions, with a proposed budget of \$250,000.

The project will be implemented by the City of Springfield Department of Parks, Buildings and Recreation Management. The Parks Department has the experienced personnel to implement park renovation projects. The Department will engage the services of landscape designer/engineering firm to produce construction documents for this project. The construction contractor will be selected through a bid for public construction issued by the City of Springfield Office of Procurement on behalf of the DPBRM.

Recently the DPBRM has completed renovation of Blunt Park, Venture Pond (Phase 1), Westminster Street Children's' Park, Angelina Park and other similar CPA projects.
