The Forest Park Aquatic Garden Gazebo project will restore a gazebo structure that was damaged in the 2011 snowstorm and has been closed since that time. Due to its pagoda-like design, the roof was unable to carry the heavy snow load, which caused the gazebo to collapse. Proposed renovations include structural improvements, replacement wooden floorboards, trellis and roof, as well as landscaping improvements.

This project is best aligned with the open space & recreation category of the Community Preservation Act and its goals to restore the gazebo for passive recreation, The impact of this project will be

immediate, as the gazebo is highly visible and in its deteriorated state does not lend itself to the beauty of Forest Park.

Project costs are anticipated at \$130,000 for the design and construction of the gazebo. This budget allows for design, permits if necessary, materials and prevailing wages for reconstruction of the gazebo. The Department of Parks, Buildings & Recreation Management is requesting Community Preservation funding of \$110,000, with an additional \$20,000 from the park trusts, to restore the Forest Park Aquatic Garden Gazebo.

B. Proposal Description

1. Describe the proposal and how it will benefit Springfield. (200 words or less)

Forest Park is Springfield's, and the region's, largest municipal park with an annual visitor rate of 1,200,000 park patrons. The pedestrian only Aquatic Garden is a long-favored park attraction as it offers a tranquil and inviting setting for park visitors to escape the bustle of city. The Aquatic Gardens were once the grounds of Everett Barney's estate and its circular, winding paths with aquatic ponds are the design of Barney himself. When the City of Springfield restored the Barney Carriage House in the 1990's, a gazebo was constructed at the entrance to the Aquatic Garden to compliment the covered bridge and aesthetic of the gardens, and to offering park patrons a restful location to enjoy the beauty of Forest Park.

Restoration will improve the structural function of the gazebo while enhancing the entrance to the Aquatic Garden. In its original construction, the gazebo offered a tiered roof design that was unable to withstand significant snow levels, which caused the support beams and railings to buckle and collapse during the October 2011 snowstorm. Since that time, the gazebo has been closed to the public for safety reasons. For twenty plus years the gazebo provided a welcoming, picturesque amenity to the garden that was in keeping with the area's intention of passive recreation. The Amphitheater, adjacent to the gazebo, is the location of the Summer Concert Series, a free weekly concert series in June that draws hundreds of visitors of all ages and demographics to Forest Park. The gazebo is a prominent fixture in the backdrop of the amphitheater, and its restoration will improve the setting in which is located.

2. <u>Identify what CPA criteria this proposal achieves and how they are accomplished.</u>

The Forest Park Aquatic Garden Gazebo project addresses the preservation, rehabilitation and restoration of an open space and recreation amenity as outlined in the Springfield Community Preservation Plan. The improvements aim to restore the existing debilitated conditions at the Forest Park Aquatic Garden Gazebo in order to increase functionality and to beautify and restore the park to its full potential as a regional park and asset to Springfield's open space inventory.

The Project is consistent with the priorities identified in the Community Preservation Plan. The rehabilitation of the gazebo addresses the following plan criteria: to preserve and enhance the essential character of Springfield, to protect open space and recreational resources that may otherwise be threatened, serves more than one CPA purpose, to demonstrate a practical and feasible project that can be implemented within its proposed budget and schedule, to leverage public and/or private funds or voluntary contributions of goods and services, and to utilize Springfield based resources. The project has received endorsements from municipal boards and departments, as well as neighborhood support.

3. <u>Describe the need that this proposal will address.</u>

PBRM has identified the continued further development of the Forest Park masterplan and the Forest Park buildings and structures as goals of its Open Space and Recovery Plan (2017). Rehabilitation of the Forest Park Aquatic Garden Gazebo will address these goals specifically. The Open Space plan is developed with community and resident input and PBRM continually strives to address the recreational needs of the city when completing park renovation projects. Additionally, the Forest Park Aquatic Garden Gazebo is listed in the City's Capital Improvement Plan, to be completed once funding is available.

Once a prominent feature of the Aquatic Gardens, the gazebo has been closed to the public since the October 2011 snowstorm. There is community and neighborhood support and interest in restoring this park feature, which has been delayed due to lack of funding. Please see attached letters of support from the Forest Park Civic Association and ReGreen Springfield.

4. What is the expected outcome of this proposal?

Completion of this project will produce construction ready documents and restoration of the Forest Park Aquatics Garden Gazebo. As Forest Park is the City's largest open space, with 736 acres of park and recreation land and the Gazebo's location at entrance to the Aquatic Gardens in Forest Park, the restoration project will have an immediate and highly visible impact that will increase Forest Park's draw as a regional destination and restore the picturesque Victorian atmosphere in this section of the park.

Through this proposal, the gazebo will be rebuilt and reopened to the public for their enjoyment. A sample of tasks may include design and engineering, permits if applicable, purchase construction materials and labor costs.

C. Feasibility & Sustainability

- 1. What other funding sources have been secured or are being pursued?
 - a. The development of the Forest Park Aquatic Garden Gazebo has been previously supported by the Barney Trust. The project's anticipated budget is \$130,000. At this time, the Trust is able to support this project with up to fifteen percent of the project cost, anticipated at \$20,000; the remaining eighty-five percent of the project cost is being requested from the Community Preservation Act, budgeted at \$110,000, through this grant application.
- 2. Once the proposal is complete how will it be sustained/maintained?
 - a. The Forest Park Aquatic Garden Gazebo will be maintained and operated by the Department of Parks, Buildings and Recreation Management under the direction of Board of Park Commissioners.
- 3. Is there an operating pro forma for when the proposal is complete and what is the basis?
 - a. No, there is no operating pro forma for this project.

D. Applicant Experience

1. What similar projects/programs has the applicant successfully completed?

The Department of Parks, Buildings & Recreation Management will coordinate and oversee all aspects of the Aquatic Garden Gazebo restoration project. PBRM has a long history of successfully completing park improvements and renovation projects.

Furthermore, PBRM plans to utilize its on-call design firms and to procure necessary engineering plans and materials to successfully complete the restoration of the Gazebo. Most recently, the Parks Department completed the renovation of Forest Park's Swan Pond culvert, a \$3.5 million project.

The Parks Department and Great Country Timber Frames, also known as The Barnyard, have collaborated on multiple successful projects similar to this gazebo renovation project. Two such projects are the in the installation of a pavilion at Gunnery Sergeant Thomas J. Sullivan Park in East Forest Park and the Pavilion at Franconia Golf Course in the Forest Park neighborhood.

2. Describe the professional experience of the applicant/project team.

All projects of PBRM are overseen by its Executive Director, Patrick Sullivan, who has over 25 years of experience in park renovations and improvements. The department will work with the Office of Procurement to issue a request for qualifications to complete the necessary designs, permits and construction documents. In the past five years, PBRM has completed twenty similar projects, resulting in approximately \$12,000,000 in park improvements.

Working through the City's procurement regulations, the renovation of the Forest Park Aquatic Garden Gazebo will be publicly bid for construction by a qualified vendor.

Working through the City's procurement regulations, a request for qualifications and proposals will be issued for PBRM to hire a design and engineer firm to complete construction documents for the rehabilitation of the Gazebo.

Dear Members of the Board of Park Commissioners and Executive Director Sullivan,

As you will probably recall, prior to 2011, **Forest Park** had a well-crafted *gazebo* overlooking the aquatics pond located south of Barney Carriage House. As a consequence of the infamous Halloween snow and ice storm in October of that year, the *gazebo* collapsed and was subsequently removed. The site is now closed, although children have to be reminded constantly to avoid playing on the foundation, which is dangerously tempting given its location on the water.

Bill Malloy and Nancy Francisco, both Forest Park residents, are supporting an effort to obtain *Community Preservation Act* (**CPA**) funding to reconstruct a new, weather-resistant gazebo on this site which was frequently used as the backdrop for many of the weddings held in Forest Park. The estimated cost is \$150,000 for design, engineering, materials and construction.

At its 11 March 2020 monthly meeting, the board of the *Forest Park Civic Association* (**FPCA**) voted unanimously to (a) support this proposal; (b) requests the Board of Park Commissioners to do likewise; and (c) asks *the Department of Parks, Buildings and Recreation Management* to add the *Forest Park Aquatics Gazebo* project to its list of citizen requests for **CPA** funding. In our view, this project offers us an excellent opportunity to remove a current eyesore and potential hazard in our iconic park. More positively, if executed, this project will restore one of the Park's most laudable and popular features for the enjoyment of current and future generations.



Historic Forest Park, with its natural, cultural and recreational benefits to the community will be greatly enhanced by this addition to the lower park area, which will be designed and built with a respect and appreciation for the aesthetic and historic value of the structure. It will be a great addition to the Park and will help restore the Aquatic Gardens as a key element of the park experience and landscape.

ReGreen Springfield conducts many programs in Forest Park each year, and we know that the new gazebo will provide an enhanced opportunity to help facilitate our educational, outdoor adventure and after-school programs that we offer to Springfield residents. It is important to our mission to support the efforts of the City and our neighborhood partners to enrich the quality of life for Springfield's residents.


Forest Park Plot Map
