1. What steps will be taken to ensure the work complies with the Secretary's Standards?

As the Spanish American War Memorial Monument is located in Memorial Square, a National Historic Register neighborhood, and the monument itself is listed on the State's Inventory of Historic places, the project will follow the recommended standards as described in the Secretary of the Interior's Standards for the Treatment of Historic Properties.

The Spanish American War Memorial Monument Rehabilitation project falls under the Building Site Standards of the document:

# A property shall be used for its historic purpose, its historic character preserved and its historic significance retained and preserved.

The project aims to restore and preserve the condition of the granite and bronze Spanish American War Memorial Monument, located at the intersection of Plainfield, Main and Bradford Streets in Springfield's Memorial Square neighborhood, as a means of connecting the public to this open space. Through restoration work on the base, plaques and the statue, the monument and its historic properties will be preserved. The project will also include an evaluation of the monument by a qualified conservationist/historic preservationist to make recommendations for the condition of and treatments for the restoration of the Spanish American War Memorial Monument.

# Distinctive features, finishes and construction techniques or examples of craftsmanship that characterize a historic property shall be preserved.

The historic craftsmanship of the bronze work will be honored, with special attention to the bronze soldier statue and remembrance plaques. The stone base and monument will undergo restoration efforts as needed, and the surrounding landscape and walkways will be enhanced.

# *Providing continued protection and maintenance of buildings and landscape features on the site through appropriate grounds or landscape management*

The Department of Parks, Buildings and Recreation Management will enhance and maintain the brick paver walkways and landscaping surrounding the Spanish American War Memorial Monument. It is proposed to design and install a plaque that explains and honors the Memorial Square neighborhood as a National Registry of Historic places.

- 1. What is the age of the property?
  - a. The Spanish American War Memorial Monument was constructed in 1906. The monument is 114 years old.
- 2. Will the owner agree to a preservation restriction or local historic district designation?
  - a. Yes. The Department of Parks, Buildings & Recreation Management is dedicated to the preservation the City's historical monuments and markers. The Spanish American War Memorial Monument is located the Memorial Square historic district and is listed on the State and National Historic Registers, see attached historical registration information.

A. Project Summary

The Department of Parks, Buildings and Recreation Management (PBRM), through this grant opportunity, aims to restore and preserve the Spanish American War Memorial monument located in the Memorial Square neighborhood at the intersection of Main Street, Plainfield Street and Bradford Street. The monument has greeted visitors to the North End of Springfield for 114 years and will continue to enhance the character of Springfield with its restoration.

The Spanish American War Memorial, constructed by Melzar Hunt Hosman in 1906, is an 8'ft bronze sculpture of a soldier walking and carrying a gun on a 10'x10' granite base, with four bronze remembrance plaques, one on each side. The Memorial was erected in remembrance of the  $2^{nd}$  Massachusetts Infantry in the War with Spain (1898).

PBRM is requesting Community Preservation funding to perform restoration work to preserve the granite and bronze elements of the monument and to make improvements to the terrace in which the monument is situated. The project will include the hiring of an historic preservation consultant to perform a conditions report of the monument and make recommendations for treatments. The results of the study will indicate the necessary rehabilitation work needed to preserve the monument.

#### B. <u>Proposal Description</u>

#### 1. Describe the proposal and how it will benefit Springfield. (200 words or less)

Springfield has a long and proud history of military service and remembrance. Preservation of the Spanish American War Memorial Monument will ensure the sacrifices of city veterans are acknowledged and honored for future generations. The Spanish American War Memorial Monument has been a historically significant marker within the city for over one hundred years. Since that time, it is witnessed the evolution of the City's urban expansion and renewal. Situated at the gateway to the Memorial Square neighborhood the monument is highly visible to city residents and visitors alike.

It is the intent of PBRM to initiate a historic conditions report, design documents, costs estimate and restoration work to rehabilitate the Spanish American War Memorial Monument with a grant from the Community Preservation Commission.

#### 2. Identify what CPA criteria this proposal achieves and how they are accomplished.

The Spanish American War Memorial Monument project addresses the preservation, rehabilitation and restoration of an historic open space amenity as outlined in the Springfield Community Preservation Plan. The improvements aim to renovate the existing conditions at the Spanish American War Memorial Monument in order to beautify and restore the monument to its full potential as a historically significant asset to Springfield's open space inventory.

The Project is consistent with the priorities identified in the Community Preservation Plan. The restoration of the monument addresses the following plan criteria: to preserve and enhance the essential character of Springfield, to protect open space and recreational resources that may otherwise be threatened, serves more than one CPA purpose, to demonstrate a practical and feasible project that can be implemented within its proposed budget and schedule, to leverage public and/or private funds or voluntary contributions of goods and services, and to utilize Springfield based resources. The project has received endorsements from municipal boards and departments.

#### 3. Describe the need that this proposal will address.

PBRM has identified the restoration and preservation of all city owned monuments as an on-going goal of its Open Space and Recovery Plan (2017). Rehabilitation of the Spanish American War Memorial Monument will address this goal specifically. The Open Space plan is developed with community and resident input and PBRM continually strives to address the recreational needs of the city when completing park renovation projects. Additionally, the restoration of all city owned monuments, including the Spanish American War Memorial Monument, is listed in the City's Capital Improvement Plan, to be completed once funding is available.

#### 4. <u>What is the expected outcome of this proposal</u>?

Completion of this project will implement a preservation and restoration plan for the Spanish American War Memorial Monument. Restoration work will follow the guidelines and recommendations in the Secretary of the Interior's Treatment of Historic Properties by a qualified consultant and vendor. Hands-on restoration work will be completed, and the terrace will be enhanced to provide an improved setting

for the display of the monument. As the Monument is located at entrance to the Memorial Square neighborhood, the restoration project will have an immediate and highly visible impact that will increase the aesthetics of this densely populated and highly traveled section of the city.

The following steps may be completed as an outcome of this proposal:

#### **Overview of treatment procedures**

1. Inspection and report written by a conservation professional that would include a detailed list of tasks, treatments and approved materials by a qualified professional.

2. The conservator will inspect the memorial and provide the city with a report detailing the condition and the approaches to treatment that they will take.

The objective of the treatment is to repair any structural damage on the bronze and stone (if needed). This can be determined on an up-close inspection which may indicated that the following are needed:

- Repair cracks in bronze, remove Iron Chaplets in bronze, check to make sure the sculpture/plaques are mounted securely, repair mortar or lead joints, identify any missing elements that may have been removed from the bronze (swords, straps, etc.) and recreate and re-attach these elements;
- Restore the surface of bronze to the original/intended surface finish and apply a coating which will protect the surface from environmental degradation; remove superficial corrosion products, repatina surface to a statuary brown by the application of traditional patina solutions and techniques (research should be done to determine appropriate brown tone), application of a an acrylic coating formulated for use on out-door copper alloys
- Clean stone without using acidic cleaners which can cause lasting damage to stone surface; test appropriate cleaners and proceed using the safest cleaning solution which can remove soiling and accretions.

#### C. Feasibility & Sustainability

- 1. What other funding sources have been secured or are being pursued?
  - a. At this time no other funds are anticipated and the department is requesting one hundred percent of the design and restoration costs through this grant application.
- 2. Once the proposal is complete how will it be sustained/maintained?
  - a. The Spanish American War Memorial Monument will be maintained by the Department of Parks, Buildings and Recreation Management under the direction of Board of Park Commissioners.
- 3. Is there an operating pro forma for when the proposal is complete and what is the basis?
  - a. No, there is no operating pro forma for this project.
- D. Applicant Experience
  - 1. What similar projects/programs has the applicant successfully completed?

The Department of Parks, Buildings & Recreation Management will coordinate and oversee all aspects of the Spanish American War Memorial Monument restoration project. PBRM has a long history of successfully completing park improvements and renovation projects.

Furthermore, PBRM plans to procure the services of a qualified restoration firm to ensure all work and materials are in keeping with the guidelines indicated by the Secretary of the Interior to successfully complete the restoration of the Monument. The minimum qualifications would be 10 years' experience treating historic bronze and stone memorials, a list of 5 projects which are similar in scope to this project, references from past projects and proof of membership to the *American Institute for Conservation of Artists and Historic Works* (AIC)—the project manager should be a Professional Associate or Fellow.

2. Describe the professional experience of the applicant/project team.

All projects of PBRM are overseen by its Executive Director, Patrick Sullivan, who has over 30 years of experience in park renovations and improvements. The department will work with qualified consultants and designers to complete the necessary construction and landscaping plans. In the past five years, the DPBRM has completed twenty similar projects, resulting in approximately \$10,000,000 in park improvements.

Working through the City's procurement regulations, a request for qualifications and proposals will be issued for PBRM to hire a consultant firm that is knowledgeable in restoring historic structures to complete construction documents for the rehabilitation of the Monument.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Memorial Square District is located in the northwestern section of Springfield at the western section of Main and Plainfield Streets. Six of the seven district buildings are loosely grouped around this intersection, with Memorial Church acting as the focal point. Four of the buildings are public and commercial structures dating from the 1890's and the first decade of the 20th century. Also included in the district are two Queen Anne houses built during the 1880's, a small park, and the Memorial Square island at the intersection of Main and Plainfield Streets. The area is surrounded by residential and commercial buildings, and an urban renewal region to the southwest.

<u>MEMORIAL CHURCH</u> (#1) is an imposing Gothic Revival structure designed by Richard Upjohn and his son, R. M. Upjohn and was completed in 1866. The church was constructed of local materials, primarily grey Monson granite with Longmeadow brownstone trim. Fenestration is varied. The larger windows are Gothic arched; the smaller are trefoil arched. There are 10 feet diameter rose windows in the gable ends of the transept and in the northern end gable. Two entrances on both the east and west elevations are highlighted by archivolts with alternating light and dark stone voussoirs. The slate roof is polychromatic. The church has a cruciform plan with an hexagonal apse to the south. Between this hexagonal apse and the eastern wing of the transept rises a granite tower with ornate brownstone trim in the belfry. The tower is capped by a multifoil brownstone balustrade. There are two subsidiary rooms flanking the nave at the northern end of the church, each one story high with a Mansard roof.

At each angle of the hexagon apse is a buttress extending up from the foundation and terminating in brownstone capped pinnacles. These pinnacles rise to the same height as the five Gothic style dormers which crown the hip roof of the hexagon.

MEMORIAL SQUARE LIBRARY (#2) was designed by Edward Tilton of New York, and two local architects, E. C. and G. L. Gardner. It was built in 1914 in an adaption of the Italian Renaissance style. The building is of buff brick ornamented with limestone. It is capped by a red tile hip roof with widely projecting eaves and exposed raflers.

The center entrance on the symmetrical east facade is flanked by three bays. It is distinguished by a dentiled entablature headed by modillions beneath the projecting cornice which is supported by stone scroll brackets. A limestone stringcourse separated the partially exposed basement from the floor above. Fenestration is recessed panels containing double windows over a smaller 1/1 window. These window panels are defined by brick pilasters with limestone capitals. The entablature of the building is decorated by a corbelled table. The building is four bays deep. It has recently been purchased privately, and will house a funeral home.

#3 is a small triangular park in front of the library in which stands a Spanish-American War Memorial statue. It is of bronze, and portrays one of Springfield's "Boys of '98", replete with bedroll, cartridge belt and pouch, food packs, canteen, and Springfield rifle. The designer was Melzar H. Mosman of Chicopee.

THE SPRINGFIELD STREET RAILWAY BUILDING (#5) was designed by the local architectural firm of Gardner, Pyne, and Gardner, and was built in 1897. A two story office building of buff brick with a granite foundation and brownstone and terra cotta trim fronts and adjoins a large brick car barn. The twenty bay wide facade faces west toward Main Street. The northern end is a six bay wide section which is a 1/2 story shorter than the main section. It contains a three bay wide car entrance. Two windows and a door are headed by a continuous brownstone lintel on the first story. Triple arched windows on the second story are headed by a continuous segmentally arched cornice. An off center arched entrance-way dominates the facade. Its double doors are recessed behind a massive brownstone and terra cotta arch. The crown of the arch is decorated with stylized trolley wheels radiating electric bolts. The entrance is flanked by double windows headed by brownstone lin<sup>te</sup>ls. These in turn are flanked by triple arched windows with fanlights headed by delicately detailed projecting arched cornices and tied together by ornamented terra cotta imposts. All of the first story windows have brownstone sills. A brownstone stringcourse defines the first and second story. The second story, directly above the entrance section, is composed of five bays with linked terra cotta archivolts. To either side of these is a group of segmentally arched windows headed by vertical brick voussoirs and a terra cotta cornice. These six windows are each crowned by a floral terra cotta tile. These tiles and a central terra cotta frieze are separated from the second story by a brownstone stringcourse. The central frieze is surmounted by a brownstone parapet. All of the second story windows are tied together by a continuous brownstone sill.

The south elevation of the office building is identical to the two sections flanking the facade entrance, with the exception of the first and second floor windows in the center of this three bay section which are replaced by terra cotta frames over the brick sheathing.

THE MEMORIAL SQUARE BUILDING (#6) is a six story structure built in 1911. The first story is faced with limestone, and houses stores. The five stories of apartments

above are brick. The facade faces west toward Main Street. It is accented by oriel windows which run from the second through the fifth stories in height. Limestone trimwork ornaments the fifth and sixth stories. Glazed yellow brick decorates the top floor.

THE MEMORIAL CHURCH PARISH HOUSE (#7) was designed in the classical Revival style by Springfield architect, F. R. Richmond, and built in 1894. The two story brick building has a hip roof. The facade faces west toward Main Street. Its three bays are defined by four brick Doric pilasters. Six stone steps lead to the arched recessed center entrance. Double wooden doors are headed by a fanlight. The arch itself is supported by simple engaged brownstone columns. The entrance is headed by a tripart window on the second story. It is framed by a brownstone sill and lintel, and is divided by short engaged brownstone columns. To either side of the center section is a triangularly pedimented gable section. These pediments are each ornamented by a dentiled cornice and a corbelled triangle in the center of the typanum. Both of these bays contain two windows in the exposed basement story, a tripart window with transoms on the first story, and a Palladian window surmounted by cut brownstone and ornamental brick archivolts with keystone on the second story. All four of these windows have rough brownstone sills and lintels, and are separated into their three parts by brownstone columns. A continuous brownstone frieze runs across the facade and bears the inscription "Memorial Church - 1894 - Parish House". This is headed by a dentiled cornice.

The north elevation has a triangularly pedimented section resembling the two on the facade, except that it is larger, and is divided into three parts by brick engaged columns. The second story windows in this section are arched with brownstone architraves and ornamental brick archivolts. These three windows contain stained glass. The center Palladian window glass is from Tiffany Studios. The entire section projects slightly from the remainder of the elevation, and has three bays of double windows and a scaled down version of the facade entrance.

The south elevation is similar to the north; it has no entrance, nor stained glass. A roof balustrade encircles the building between each pediment.

THE R. HALE SMITH HOUSE (#8), built in 1883, is believed to have been designed by local architects F. R. Richmond and B. H. Seabury. The two and a half story Queen Anne style house is of red and black brick, with terra cotta, and cut glass in stucco ornamentation, and brownstone trim. The slate roof is irregular with

intersecting gables and gablets, Continuous stringcourses and bands run around the building tying all the window sills and cornices together. Rough brownstone separates the exposed basement from the first story. All of the first story windows have stained glass transoms.

The facade faces east toward Main Street. It has two projecting bays. The southern 2<sup>1</sup>/<sub>2</sub> story bay is topped by a gable supported by delicate brackets. The bay is decorated by a large three part terra cotta design between the first and second story windows; a matrix of geometrically designed terra cotta tiles between the second story windows and those in the gable; a semi circular mosiac of cut glass above the gable window, and a triangular terra cotta design in the gable peak.

The northern two story bay is narrower. It is capped by a small hipped gable containing a mosaic of cut glass. The bay is fronted by a ridge roof, open, one story porch with balustrade. In the porch gable is a mosaic of small cut stones in the radiating fan pattern. The floor is made up of ornamental cut tile.

The south elevation has a central projecting rectangular bay topped by a cross gable. The bay is ornamented by a checker board pattern of red and black brick butt-ends between the two windows on the second floor, and a mosaic of cut glass interspersed with diagonal lathing above the double window in the gable. The east end of the elevation has a one story shed roof porch with turned balustrade. Above this is a single window on the second story. Immediately west of the projection are two small wooden frame balconies with balustrades, one on the first floor, one on the second.

A tall chimney projects to the west of the balconies. The first story portion of the chimney features a large floral terra cotta panel, defined by a black brick band below and above.

The north elevation is similar to the south, but has no porches or chimney. In place of the chimney are three narrow stained glass windows in an ascending senes between the first and second stories.

A terra cotta cornice runs beneath the eaves on the north and south elevations. Beneath this is a frieze of red bricks on end, diagonally placed and outlined by black brick, which extends around the corners to the facade.

A two story brick ell projects from the east (rear) elevation. It is ornamented with black brick banding, brownstone sills and lintels, floral terra cotta, and decorative shingle patterns in the gable.

Finials and iron cresting have been removed from the roof of the house.

THE E. S. SWEATLAND HOUSE (#9) was built in 1886 in the Queen Anne style. It is also believed to have been designed by F. R. Richmond and B. H. Seabury. The 21/2 story brick structure is of the same overall form as the Smith House (#8) except for modification of the facade and a more sparing use of ornamentation. The entire house has been painted white, with all brownstone trim painted black. Rough cut brownstone is used for all window sills and lintels and for a stringcourse defining the basement and first floor. The lintels on the first and second story windows are connected by terra cotta tiles, as are the sills on the first story. The first story lintels are connected by decorative cut black brick butts.

The facade faces west toward Main Street. It contains two projecting bays which are joined by the large third story gable. Cornice brickwork is used to create the effect of a broken pediment in the gable with terra cotta tiles as trim inside. A one story ridge roof porch with balustrade projects from the northern end. It is of the same design as that on the Smith House but the mosaic pattern in the gable is varied.

The south elevation has the same chimney, gabled bay, and porch arrangement as the Smith House. The gable contains only one window, and has the same brickwork design under the eaves as that on the facade.

The north elevation is like the south, without the porch and chimney.

A two story brick ell identical to the one next door on the Smith House projects from the rear elevation.

The buildings which compose the Memorial Square District have changed very little over the years, but the surrounding area has been altered significantly. Round Hill, to the northwest of Memorial Church has been levelled. A bottling plant

was built directly behind Memorial Church in the late 1940's.

Interstate 91 and its ramps curves through the area. Widening of roadway and Dutch Elm disease destroyed many of the trees that shaded the Square and made up the Main Street terrace. The urban Renewal and Interstate 291, south of the Square caused severe drop in population.

#### STATEMENT OF SIGNIFICANCE

The Memorial Square District is significant both as the focal point for the two northwestern neighborhoods - Brightwood and North End - of Springfield and for its architecture. It contains work of two nationally prominent architects and several of Springfield's top architects of the turn of the century. Notable structures include the Trolley Barn, the branch public library, and the Memorial Church.

Until the latter part of the nineteenth century, Memorial Square was primarily defined by a north-south drumlin known as Round Hill. Roads leading north from Springfield split just south of the hill, with the eastern branch (North Main Street) continuing the path of Main Street to Chicopee, and the western branch (Plainfield Street) swinging westerly through the broadened flood plain of the Connecticut River to the river's banks and then northerly to Chicopee. After the Civil War, Round Hill began to be developed into three large estates for prominent city families. The area just south of the Square was also built up during this period, but with less affluence. A physical link was established with downtown through a green space, numbering the length of the middle of Main Street. This terrace, approximately twenty-five feet wide, and having a central row of trees, began at Memorial Square. In 1877 the North End Bridge was constructed where Plainfield Street first approaches the river bank, thus linking the developing northern district of Springfield with West Springfield.

The religious society which later became affiliated with the Memorial Church (#1) was organized in 1865 through the efforts of Christian laymen, principally, George Atwater and Dr. J. G. Holland. Mr. Atwater, who has a seven hundred acre estate at the northern edge of town, was the head of the Springfield Street Railway, and owner of the Glasgow Mills in Ludlow. He later wrote that during the '60's, as this section of town was developing, he noticed that no provision was being made for a church and, concerned for the spiritual welfare of these citizens, began organizing for one. He donated \$18,000 and a large amount of his time to these efforts. His neighbor and good friend, Dr. Holland, was a leading member of the town's literati. He was associate editor of the Springfield Republican, a nationally respected newspaper at this time, and a wellpublished poet, novelist and historian. A Sunday School formed in 1865 had Dr. Holland as its superintendant. The religious society was formed as a Union Evangelical Church and when the church was built it was dedicated to the memory of the deceased ministers of New England. These ministers, as well as George Atwater, are memorialized in the Tiffany stained glass windows.

This church was the first of five started in the city during the building boom following the Civil War. Springfield, because of the presence of the U.S. Armory, had prospered during the war, and this prosperity was now made visible. Mr. Atwater acquired the services of Richard Upjohn, the renowned Gothic revival architect of the middle nineteenth century, for Memorial Church. Upjohn was devoting most of his time to the functionings of the American Institute of Architects, which he had helped found in 1857. More and more of the commissions he received in these years were being given only cursory attention. This was due in part to the active part played by R. M. Upjohn, the elder Upjohn's son, who became associated with his father in 1858 and dominated the firm in the years following the Civil War. Obvious Victorian additions, representing the son's influence, are the striped slate of the roof and the banded arches of the entranceways. Nonetheless, Richard Upjohn considered this an important commission and is known to have worked on the design himself. In fact, this is considered his last completed ecclesiastical building. The firm used local carpenters, but the masons, Ponsonby and Maginn, were from New York. These masons were to work on H. H. Richardson's first commission, the Church of the Unity, in Springfield during the same period.

The <u>Memorial Square Library's</u> (#2) principal architect, Edward Tilton, is also connected with other public buildings in the city. In 1908 he won the design competition for the present City Library, and during the early 1930's designed the Museum of Fine Arts and the extensive addition to the Museum of Natural History which completed the city's cultural area known as the Quadrangle. All of these buildings are in the Quadrangle-Mattoon Street National Register District.

Tilton trained with the firm of McKim, Mead and White and attended the Ecole des Beaux Arts in Paris. He was particularly involved in library design throughout his career which spanned four decades beginning in 1890, and his work extends through most of eastern United States. His is listed as one of the founders of the National Beaux Arts Society of Architects.

The <u>Street Railway Company's</u> (#5) designer, Eugene C. Gardner, the senior partner of Gardner, Pyne and Gardner was Springfield's best known and most influential architect during the late nineteenth and early twentieth centuries. He has been referred to as "one of the last of the important pattern book authors" and again "that antistylistic, utilitarian pattern of thought which had been a product of

mid-century romantic rationalism and which reached its middle 70's peak in E. C. Gardner". No other single architect contributed as much in bringing Springfield into the twentieth century. His career spanned half a century, from the 1860's until the second decade of the twentieth century, all but the first four or five years in this city.

Gardner's early training had been as a mason and school teacher, both of which are well illustrated in his later career. He is first listed as an architect in Florence, Massachusetts (a village of the city of Northampton) in 1865.

The <u>Memorial Church Parish House</u> (#7) architect, Francis R. Richmond, began his building career as a carpenter in the Amherst area. In the early 1870's he came to Springfield and worked under E. C. Gardner until 1882. In that year he formed a partnership with B. Hammett Seabury, a recent graduate of Boston Tech. During their partnership their designs incorporated many elements from Queen Anne and Romanesque styling. This partnership lasted until 1890.

Melzar H. Mosman worked for the Ames Sword Manufacturing Company in Chicopee for seventeen years. This experience aided him in starting his own career as a sculptor and foundry man. He considered the <u>Spanish-American War Memorial</u> (#3) his finest work. He also designed the GAR Memorial in Court Square.

<u>R. Hale Smith</u> (#8) was a local industrialist and inventor. At his death his "business...practically the largest of its kind in the world, and the products are shipped to all parts of the globe". He was the inventor of the "motometer", a device which determined the speed of autos and the distance traveled. He was active in local politics as a member of City Council and of the Board of Public Works. After Mr. Smith died in 1908 the house was occupied by Dr. Seth A. Lewis for fifty years. He practiced medicine in Springfield for sixty-three years and was the physician for the Street Railway Company for over thirty years. <u>Edgar</u> Sweatland (#9) was in the whip manufacturing business in Westfield.

The turn of the century was Springfield's major period of growth and development. The <u>Street Railway Company</u> (#5) was very instrumental in this growth. The Street Railway's Main and Carew Street Building is a direct result of this growth, as the late 1890's were the peak period for this company. The Street Railway Company sold the structure in 1958 to a locally based interstate bus company which used it as a garage until the early 1970's. It is now being leased for automotive repair.

During the same time period a pressing need for a library was felt. The North End was Springfield's immigrant center throughout the nineteenth century as each successive group made their first stop here. This development was at its peak at the beginning of the twentieth century. The resulting Memorial Square Library (#2) was second only to the central library in size and scope. It served the neighborhood as a public facility for over fifty years.

Memorial Church (#1) and Parish House (#7) were sold to the Greek Orthodox Church in the late 1930's. Both structures have been owned by this religious group since then. The two residences (#8 & #9) were bought by the North End Drug Abuse Program in the early 1970's and are presently being used by them.
