HDR Architecture, Inc., the selected design firm is currently working on the schematic design phase of the project. Final design is anticipated to be completed by February, 2013. Construction documents for the purpose of obtaining a Guaranteed Maximum Price (GMP) proposal will be available at that time. Construction work is anticipated to begin in April, 2013. The project is projected to be completed and ready for operations by July, 2014. It is anticipated that the CM will be under contract during the design development and contract document phases to provide Pre-Construction services. This RFQ includes Pre-Construction services. SRA will work with the successful CM at Risk firm to negotiate Pre-Construction services. The actual construction phase is anticipated to be approximately 16 months.
