The City of Springfield, through the Office of Community Development, has prepared its DRAFT Five Year Consolidated Plan for the program years July 1, 2010-June 30,2015 and DRAFT Annual Action Plan for program year July 1-2010-June 30, 2011 (“The Plans”). The DRAFT Plans outline the strategy and planned expenditures of the Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG), HOME Investment Partnership Program (HOME) and Housing Opportunities for Persons with AIDS (HOPWA) formula grant programs received by the Department of Housing and Urban Development (HUD).

The DRAFT Plans will be available for a 30-day public review period beginning April 8, 2010 through May 7, 2010.
