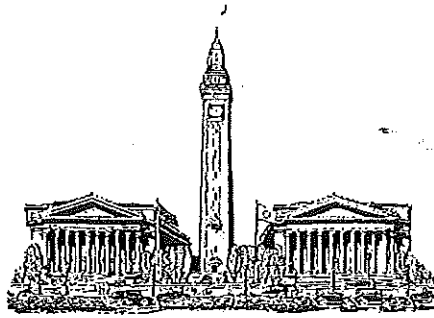

Re: Temporary Fencing for MGM Project

The following are additional requirements to be included with Permit 20150262, issued on March 18, 2015:

- 1) Permit 20150262 must be renewed in 2 month increments, phases will be added as they are approved.
- 2) Permit to be provided for Phase 1-4
- 3) Fencing on phase 3 and 4 within street cannot be completed until street discontinuance process is complete (ie: written notification from DPW).
- 4) Fencing on Main St. cannot be installed until approval is provided by PVTA.
- 5) City to be provided all existing signage and poles to be removed.
- 6) Any modification to proposed fence line must be approved by the City of Springfield prior to any change.
- 7) Parking signage modification shall only be implemented at location when fencing is installed.
